Because of the fact that the issue of energy efficiency and usage of alternative energy sources is a topical problem for Zakarpattya, the new Programme of Energy Efficiency and Energy Saving of Zakarpatska oblast for 2012-2015 was approved by the decision of Zakarpattya Oblast Council No425 dated 02.03.2012. Aimed at implementing the Programme, the complex of activities and projects on energy saving and increasing of energy efficiency in different spheres has been developed and is being carried out. Particularly, the activities on introducing of energy saving technologies at budget institutions, applying of bioenergy and other renewable energy sources, substituting of gas with other more economically sound and environmentally friendly kinds of energy, installing of more efficient and energy saving equipment and other ones are carried out.

Zakarpattya Oblast Council by its decision No470 dated 08.06.2012 also approved the Programme of transiting of boiler houses of budget institutions to alternative fuel kinds that provides with big possibilities of co-operation with budget sector (detailed information in Ukrainian language is available: http://zakarpat-rada.gov.ua/docs/rishennya/6/10_sesion/rish_470.zip). Representatives of all self-government bodies, heads of large budget institutions, design and construction companies will be invited to participate in the Exhibition. Massive information campaign aimed at involving the population and representatives of private and state institutions of the oblast will be also carried out.
